

# INSTRUCTIONS FOR SIGNING

1. **USE A BLUE OR BLACK PEN TO COMPLETE THE PETITION FORM WITH YOUR NAME AND ADDRESS WHERE YOU ARE CURRENTLY REGISTERED TO VOTE.**

We unfortunately cannot accept electronic signatures. If you're not sure where you're registered to vote, find out at [safeandhealthyco.org/registration](https://safeandhealthyco.org/registration).

2. **SIGN YOUR PETITION IN FRONT OF A WITNESS, AND AFTERWARDS HAVE THEM SIGN YOUR FORM.**

Your witness must also be registered to vote in Colorado, so this is a great opportunity to have them complete and sign their own petition form. If you don't have a witness available, visit [safeandhealthyco.org/sign](https://safeandhealthyco.org/sign) to schedule a virtual witness signing.

3. **RETURN YOUR SIGNED FORM TO US WITHIN THREE DAYS OF SIGNING, WITH A FINAL DEADLINE OF JULY 28,**
